### **Unlimited**

#### **Unlimited Golf 7 Days A Week**

**[Individual – Non-Resident \$1,900, Resident \$1,500; Senior (62+) – Non-Resident \$1,700, Resident \$1,425; Family\* - Non-Resident \$3,100, Resident \$2,400]**

The Lake Bluff Unlimited Season Pass entitles Passholder to unlimited golf seven (7) days a week. *Cart rental is not included in this Season Pass.* Cart rental is available for \$16 (Non-Resident) and \$14 (Resident) per player per 18-hole round. Unlimited Season Passholders will receive all the benefits of the Unlimited Lake Bluff Season Pass, as indicated below.

- One Reserved Tee Time (RTT) Fee (\$100 Value)
- 14-day advance reservations
- Discounted entry fees into Lake Bluff events

### **Limited**

#### **Unlimited Golf Monday through Friday**

**[Individual – Non-Resident \$1,400, Resident \$1,150; Senior (62+) – Non-Resident \$1,325, Resident \$1,050; Junior (18&Under) – Non-Resident and Resident \$750]**

The Lake Bluff Limited Season Pass entitles Passholder to unlimited golf, Monday through Friday. *Cart rental is not included in this Season Pass.* Cart rental is available for \$16 (Non-Resident) and \$14 (Resident) per player per 18-hole round (excludes Juniors without a valid driver's license). Limited Season Passholders will receive all the benefits of the Limited Lake Bluff Season Pass, as indicated below.

- 14-day advance reservations
- Discounted entry fees into Lake Bluff events

### ***Cart Rental Add-On***

A cart rental add-on program will be available for the 2025 season. This package allows Season Pass Holders cart usage for \$800 per Individual and Senior or \$1,000 for a Family. Junior Season Passes are walking only with the exception of Juniors with a valid driver's license.

### ***Early Commitment Special!***

Lake Bluff's 2025 Season Pass Program sales drive begins Saturday, November 23<sup>rd</sup>, 2024. As a special promotion when registration is completed and dues are paid by December 20<sup>th</sup>, 2024, Passholders can take advantage of a special promotion. The Cart Rental package will be available at a discounted rate of \$500 per Individual and Senior Season Pass or \$800 per Family Season Pass when registration and payment is made by December 20<sup>th</sup>, 2024. As a bonus, passholders who register and provide payment by December 20<sup>th</sup>, 2024 will receive two complimentary foursomes to top-tier GolfVisions' facilities.

## TERMS AND CONDITIONS

- Rates, programs and privileges are valid for the 2025 season.
- Season runs from approximately April 1 – November 30 (weather-permitting).
- Rates are non-negotiable.
- Packages and privileges are non-transferable and non-refundable.
- Passholder dues must be paid in full at time of registration.
- Advance reservations are required.
- Tee times may be booked up to fourteen (14) days in advance.
- Tee times are subject to course availability.
- Twenty-four (24) hour cancellation is required.
- Passholders are required to check-in prior to tee time and before each round.
- Passholder privileges may be suspended or revoked at any time for inappropriate or unacceptable behavior.
- **Preferred Advance Reservations.** Advance tee times available up to fourteen (14) days in advance.
- Proper attire is required.
- Outing participation shall be at the fees contracted for the event.
- League participation shall be at no additional charge, if applicable.
- Special events are available for Passholder participation at discounted fees posted for each specific event.
- \*Family Memberships are limited to married couples including up to 2 children (18 and Under).
- Junior (18 & Under) Season Passes are classified as walking only. Juniors presenting a valid driver's license will be allowed to rent a cart for \$16 (Non-Resident) or \$14 (Resident) per round.
- Resident is defined as residing in Lake Bluff, Lake Forest, or Libertyville, or within the Lake Bluff Park District boundaries.
- Lake Bluff Golf Club and GolfVisions Management, Inc. reserve the right to modify the Passholder Program, at their discretion, at the conclusion of each golf season.
- Lake Bluff Golf Club and GolfVisions Management shall make every attempt to inform Passholders of scheduled outings, tournaments, and events but reserve the right to schedule functions. In most cases, a minimum advance notice of seven (7) days shall be given by Management. As stated above, advance reservations are required and may be booked up to fourteen (14) days in advance but are subject to course availability.
